WE ARE OUT OF WATER BUT WE STILL KEEP UP THIS INSANE GROWTH.

The paper below was presented before the Southern Nevada Water Authority which is composed of council members from Henderson, Boulder City, Las Vegas, North Las Vegas and three Clark County Commissioners. Pat Mulroy the SNWA Executive Director was requested to answer the six questions listed within 10 working days. She has not done so and was so notified March 10, 2003. Also at this meeting making presentations was our Larry Paulson, Ed Duffy and Ken Record, besides them were good friends Bernie Silver and Phil Testa all who did a wonderful job of telling like it is.

February 20, 2003

To: SNWA Board of Directors

Madam Chairperson and Members of the Board:

I am Ken Mahal President of Nevada Seniors Coalition. I reside at 3371 Astoria Dr. Las Vegas Nevada 89121. Please include this testimony as a matter of record. We appreciate this opportunity to present our concerns as citizens of the greater Las Vegas area.

The former Las Vegas Valley Water District seemed pretty honest and open, with its reporting of water available to match permits issued. It was comforting to know we were living within our means. However, since about 1991 under the SNWA this reporting has disappeared and in fact there seem to be a deliberate cover-up. For the billions spent the SNWA has facility duplication but no substantiated increase of water over our present 300,000 acre feet in the Colorado River. We find the SNWA is long on promises and short on results. The Greater Las Vegas Area has a need for double our water allotment so the reality is we are out of water and have no alternative but to stop growth. We also think it is time to audit your performance for public knowledge.

The SNWA seems to have given you and your board predecessors either a false sense of security or a front to hide behind. As a result you allow uncontrolled growth to sweep across this valley like a wild fire while in reality there is no water to put out that wild fire of growth.

- We petition a written response by your manager in ten working days to our questions.

 1. We petition that you produce audit proof facts proving you have water to match all land ap-
- 1. We petition that you produce audit proof facts proving you have water to match all land approved for development in the greater Las Vegas area and that you have water reserved in priority from the oldest ongoing development to the newest ones.
- 2. During the vote on the ¼% sales tax, developers were given about 20 years in a graduated scale subsidizing their actual hookup costs. We petition the SNWA to provide a fact sheet on actual costs versus subsides and ask that you increase all hookup costs to 100 % of actual costs immediately.
- 3. We petition to know in detail why the SNWA wants to put us in debt 3 billion dollars for Nevada Power when for 20% of the cost they could build a new plant.
- 4. We petition the SNWA to provide a complete list of all electric power generating deals made and proposed with the rational justifying them along with the details of upfront and final costs in consideration.
- 5. On the completion of the information in item 4, we petition the SNWA to set up public hearings for taxpayer involvement on all such power issues and (Continued on Page 2)

expenditures.

6.. We petition to know when the SNWA mission changed to be in the electric generating business and for what purpose. It bothers us that you are failing in your primary mission of matching available water with permitted growth so we question your expertise in the electric generating business.

In conclusion we have these words of concern as it relates to your performance.

THE WATER BANK IS EMPTY and GROWTH MUST STOP.

Madam Chairperson and Board of Directors:

I am Ken Mahal, President of Nevada Seniors Coalition. I reside at 3371 Astoria Dr. Las Vegas Nevada 89121.

Please include this letter and the three attachments listed below as a matter of record and for distribution to all members of the board. We appreciate this opportunity to express our concerns as citizens of the greater Clark County area.

In 1996 as President of the NSC and a retired professional registered to practice in the fifty US states I became aware of the so called second straw proposal. Upon review of the proposal I saw a multi billions dollar-engineering mistake in the making.

My immediate concerns were:

- 1. First and foremost who would build a facility next to the present one given the 1994 Cryptosporidium outbreak caused by contaminated drinking water at the existing facility?
- 2. Who would build two facilities next to each other telling the public this was for a safe water supply to the Las Vegas valley?
- 3. Who would build such a facility in Las Vegas Bay six miles down stream of the Las Vegas Wash where a predicted daily 155,000,000 plus gallons of treated sewage would be dumped into the water intake area?
- 4. Who would build a new facility in Las Vegas Bay knowing that 1,600 square miles of polluted surface drainage entered the bay six miles up stream of the pumping stations?
- 5. Who would build a facility across the lake from an extinct volcano in Arizona?

If these weren't legitimate major engineering and health issues what were they?

From the start we have backed our concerns with solutions as professionals. You and your predecessors and other elected officials chose not to listen. And you newer members will feel the brunt of the problem brewing if you do not solve the above issues as well as how to administer the proven water shortage. We still suggest you look for a safe water source in the upper Lake Meade area. And as for the proven water shortfall based on just existing permitted development we suggest you prioritize all water if any is available to the first permitted (Continued on Page 4)

TODAY IN HISTORY

March 13, 1868 - Under the direction of U.S. Supreme Court Chief Justice Salmon P. Chase, the U.S. Senate trial of President Andrew Johnson, the first president to ever be impeached, begins in Washington, D.C..

Inaugurated after Lincoln's assassination in April of 1865, President Johnson enacted a lenient Reconstruction policy for the defeated South, including almost total amnesty to ex-Confederates, a program of rapid restoration of U.S. state status for the seceded states, and the approval of new, local Southern governments, which were able to legislate "Black Codes" that preserved the system of slavery in all but its name.

The Republican-dominated Congress greatly opposed Johnson's Reconstruction program, and on March 2, 1867, passed the Tenure of Office Act over the president's veto. The bill prohibited the president from removing officials confirmed by the Senate without senatorial approval,

On February 24, the House voted eleven impeachment articles against Johnson, nine of which cited Johnson's removal of Secretary of War Edwin M. Stanton in violation of the Tenure of Office Act.

On May 16 and again on May 26, the Senate voted on the charges brought against President Johnson. Both times the vote was thirty-five for conviction and nineteen for acquittal. Because both votes fell short-by one vote--of the two-thirds majority needed to convict Johnson, he was judged not guilty and remained in office.


