Taxes, Taxes, Power and In The Hole

ALREADY YET WE ARE GOING TO TALK ABOUT TAXES ON OUR HOME.

Sharron Angle has lit the battle over our real-estate taxes and with a very good start as far as money is concerned. Her \$200,000 contribution is half way to where she wants to be in order to hire professional signature getters for the Prop 13 type initiative she is promoting with her organization We The People Nevada. By the way you can see the details in their web page www.wethepeoplenevada.org. I have mixed emotions about what is being proposed by rolling back home values to some still undetermined year and then set a 1 % property tax rate on that value and limits annual increases to 2 % a year. Presently based on what the legislature did in 2005 we have taxes frozen at the 2004 level with a maximum 3 % cap on residential property taxes and 8% on all other properties which would primarily be for income producing property. I lived with this idea of income producing property having a higher rate than non-income. I understood it but didn't like it. California Prop 13 kept people in their homes and I hope it stays that way for us because home owners and particularly retirees don't have a lot going for most of them.. I hope that isn't what is going to happen in our case. By the way take a good look at your tax statement and bring your questions to our meeting the second Thursday of September which is the 13th. We are going to have Clark County Assessor Mark Schofield as our guest speaker who can answer any questions you may have as well as be prepared to hear what he has to say on where he thinks we are best off in the years to come with our residential real-estate taxes. Those of you who were with us in 2004-5 will remember that we started the tax issue very early on out concern for higher taxes and Mark Schofield was a big help. We ended up working for the 3% cap which is what we have and if there was a way to lock that in I would be very happy to keep it that way. The problem with what we have now is that the legislature did pass the legislation that gives us this protection and by the same token the next legislature could decide to undo it and go for something much more onerous. That is something we certainly cannot afford to go to sleep on. If you pay attention to our politicians locally and at the state level you know they are always being pressed to do more of something that costs money and the two best places to get money out of our pockets is to raise our real-estate taxes and/ or to increase the sales tax. So let's wait to hear from Mark in September and go from there. In the meantime we will also be in touch with Sharon Angle to learn more about what she is thinking of for their initiative.

The Story of the Star Spangled Banner

NO REFUGE COULD SAVE: BY DR. ISAAC ASIMOV

I was once asked to speak at a luncheon. Taking my life in my hands, I announced I was going to sing our national anthem -- all four stanzas. This was greeted with loud groans. One man closed the door to the kitchen, where the noise of dishes and cutlery was loud and distracting. "Thanks, Herb," I said.

"That's all right," he said. "It was at the request of the kitchen staff"

I explained the background of the anthem and then sang all four stanzas. Let me tell you, those people had never heard it before -- or had never really listened. I got a standing ovation. But it was not me; it was the anthem. More recently, while conducting a seminar, I told my students the story of the anthem and sang all four stanzas. Again there was a wild ovation and prolonged applause. And again, it was the anthem and not me. So now let me tell you how it came to be written.

In 1812, the United States went to war with Great Britain, primarily over freedom of the seas. We were in the right. For two years, we held off the British, even though we were still a rather weak country. Great Britain was in a life and death struggle with Napoleon. In fact, just as the United States declared war, Napoleon marched off to invade Russia. If he won, as everyone expected, he would control Europe, and Great Britain would be isolated. It was no time for her to be involved in an American war.

At first, our seamen proved better than the British. After we won a battle on Lake Erie in 1813, the American commander, Oliver Hazard Perry, sent the message, "We have met the enemy and they are ours." However, the weight of the British navy beat down our ships eventually. New England, hard-hit by a tightening blockade, threatened secession.

Meanwhile, Napoleon was beaten in Russia and in 1814 was forced to abdicate. Great Britain now turned its attention to the United States, launching a three-pronged attack.

The northern prong was to come down Lake Champlain toward New York and seize parts of New England. The southern prong was to go up the Mississippi, take New Orleans and paralyze the west.

The central prong was to head for the mid-Atlantic states and then attack Baltimore, the greatest port south of New York. If Baltimore was taken, the nation, which still hugged the Atlantic coast, could be split in two. The fate of the United States, then, rested to a large extent on the success or failure of the central prong.

The British reached the American coast, and on August 24, 1814, took Washington, D.C. Then they moved up the Chesapeake Bay toward Baltimore. On September 12, they arrived and found 1,000 men in (*Continued on page 5*)

Fort McHenry, whose guns controlled the harbor. If the British wished to take Baltimore, they would have to take the fort.

On one of the British ships was an aged physician, William Beanes, who had been arrested in Maryland and brought along as a prisoner. Francis Scott Key, a lawyer and friend of the physician, had come to the ship to negotiate his release.

The British captain was willing, but the two Americans would have to wait. It was now the night of September 13, and the bombardment of Fort McHenry was about to start.

As twilight deepened, Key and Beanes saw the American flag flying over Fort McHenry. Through the night, they heard bombs bursting and saw the red glare of rockets. They knew the fort was resisting and the American flag was still flying. But toward morning the bombardment ceased, and a dread silence fell. Either Fort McHenry had surrendered and the British flag flew above it, or the bombardment had failed and the American flag still flew. As dawn began to brighten the eastern sky, Key and Beanes stared out at the fort, trying to see which flag flew over it. He and the physician must have asked each other over and over, "Can you see the flag?"

After it was all finished, Key wrote a four stanza poem telling the events of the night. Called "The Defense of Fort McHenry," it was published in newspapers and swept the nation. Someone noted that the words fit an old English tune called, "To Anacreon in Heaven" -- a difficult melody with an uncomfortably large vocal range. For obvious reasons, Key's work became known as "The Star Spangled Banner," and in 1931 Congress declared it the official anthem of the United States.

Now that you know the story, here are the words. Presumably, the old doctor is speaking. This is what he asks Key: Oh! say, can you see, by the dawn's early light, What so proudly we hailed at the twilight's last gleaming? Whose broad stripes and bright stars, through the perilous fight, O'er the ramparts we watched were so gallantly streaming? And the rocket's red glare, the bombs bursting in air, Gave proof thro' the night that our flag was still there. Oh! say, does that star-spangled banner yet wave, O'er the land of the free and the home of the brave? On the shore, dimly seen thro' the mist of the deep Where the foe's haughty host in dread silence reposes, What is that which the breeze, o'er the towering steep. As it fitfully blows, half conceals, half discloses? Now it catches the gleam of the morning's first beam, In full glory reflected, now shines on the stream 'Tis the star-spangled banner. Oh! long may it wave O'er the land of the free and the home of the brave!

"The towering steep" is again, the ramparts. The bombardment has failed, and the British can do nothing more but sail away, their mission a failure. In the third stanza I feel Key allows himself to gloat over the American triumph In the aftermath of the bombardment, Key probably was in no mood to act otherwise? During World War I when the British were our Staunchest allies, this third stanza was not sung. However, I know it, so here it is: And where is that band who so vauntingly swore That the havoc of war and the battle's confusion A home and a country should leave us no more? Their blood has washed out their foul footstep's pollution. No refuge could save the hireling and slave From the terror of flight, or the gloom of the grave, And the star-spangled banner in triumph doth wave O'er the land of the free and the home of the brave.

(The fourth stanza, a pious hope for the future, should be sung more slowly than the other three and with even deeper feeling):

Oh! thus be it ever, when freemen shall stand Between their loved homes and the war's desolation, Blest with victory and peace, may the Heaven - rescued land Praise the Power that hath made and preserved us a nation. Then conquer we must, for our cause is just, And this be our motto --"In God is our trust." And the star-spangled banner in triumph doth wave O'er the land of the free and the home of the brave.



The Nevada Senior Medicare Patrol (SMP) educates Nevadans on how to identify and protect against healthcare fraud in the Medicare/Medicaid system.

Every year the Medicare system is drained of billions of dollars as a result of fraud, waste, errors and abuse. It is the mission of the national SMP's to educate beneficiaries to identify these situations so that we can increase the chance that the Medicare system is solvent for future generations.

Examples of abuses can include, but are not limited to:

- Billing for services not received.
- Inflated billings over charging for services, or charging for a doctor when an assistant provided the service.
- Billing non-covered services as covered services billing a "nose job" as a deviated-septum repair.
- Offers of "Free" or medically unnecessary services and then billing Medicare.

Medicare beneficiaries play a vital role in detecting these instances of abuse and we rely on them to report the errors to the Medicare system.

Here are some ways to protect yourself and the system:

- Protect your Medicare number! In the wrong hands, it is a license to steal.
- Carefully review your quarterly Medicare Summary Notice – check dates of service, duplicate billings or services not received.
- Don't be influenced by advertising for services, medica-

tions, or products. Educate yourself and make your own decisions.

The Nevada SMP is funded and supported by the Administration on Aging, works closely with the Centers for Medicare & Medicaid Services and is responsible for assisting citizens across our state to identify issues to protect themselves from being victimized. We do this in a number of ways. We deliver presentations for interested parties to educate them on the signs of fraud, waste and abuse. We also recruit senior professional volunteers from the community to help. These dedicated seniors work at healthcare fairs, one-on-one counseling sessions and by networking with the state's senior service provider system to get our message into the community. Finally, we maintain a statewide, toll-free hotline (888-838-7305) so that Nevada beneficiaries have a local resource to resolve and/or investigate these complicated issues.

In addition, we provide resources and referrals to other senior support agencies and non-profits in the state.




Today In History, August 9, 1945

Atomic bomb dropped on Nagasaki

A second atom bomb is dropped on Japan by the United States, at Nagasaki, resulting finally in Japan's unconditional surrender.

The devastation wrought at Hiroshima was not sufficient to convince the Japanese War Council to accept the Potsdam Conference's demand for unconditional surrender. The United States had already planned to drop their second atom bomb, nicknamed "Fat Man," on August 11 in the event of such recalcitrance, but bad weather expected for that day pushed the date up to August 9th. So at 1:56 a.m., a specially adapted B-29 bomber, called "Bock's Car," after its usual commander, Frederick Bock, took off from Tinian Island under the command of Maj. Charles W. Sweeney. Nagasaki was a shipbuilding center, the very industry intended for destruction. The bomb was dropped at 11:02 a.m., 1,650 feet above the city. The explosion unleashed the equivalent force of 22,000 tons of TNT. The hills that surrounded the city did a better job of containing the destructive force, but the number killed is estimated at between 60,000 and 80,000 (exact figures are impossible, the blast having obliterated bodies and disintegrated records).

It was estimated by General Leslie R. Groves, head of the Manhattan Project, that another atom bomb would be ready to use against Japan by August 17 or 18-but it was unnecessary. Even though the Japanese War Council still remained divided ("It is far too early to say that the war is lost," opined the Minister of War), two War Council members eager to end the war urged Emperor Hirohito to meet with the Council, which he did, and declared that "continuing the war can only result in the annihilation of the Japanese people...." The Emperor of Japan gave his permission for unconditional surrender.
