### The Stamp Act

The Long Title: An act for granting and applying certain stamp duties, and other duties, in the British colonies and plantations in America, towards further defraying the expenses of defending, protecting, and securing the same; and for amending such parts of the several acts of parliament relating to the trade and revenues of the said colonies and plantations, as direct the manner of determining and recovering the penalties and forfeitures therein mentioned.




The Stamp Act was passed by Parliament on March 22, 1765 with an effective date of November 1, 1765. It passed 205–49 in the House of Commons and unanimously in the House of Lords. The Stamp Act of 1765 was the first internal tax levied directly on American colonists by the British government. The act, which imposed a tax on all paper documents in the colonies, came at a time when the British Empire was deep in debt from the Seven Years' War (1756-63), (which escalated from the French and Indian War in North America waged for control of the confluence of two rivers) and looking to its North American colonies as a revenue source. Arguing that only their own representative assemblies could tax them, the colonists insisted that the act was unconstitutional, and they resorted to mob violence to intimidate stamp collectors into resigning. Parliament repealed the Stamp Act in 1766, but issued a Declaratory Act at the same time to reaffirm its authority to pass any colonial legislation it saw fit. The issues of taxation and representation raised by the Stamp Act strained relations with the colonies to the point that, 10 years later, the colonists rose in armed rebellion against the British.





























# **Medicare 'Open Enrollment' Scams**

The 2015 Medicare open enrollment period runs from October 15 to December 7. It's the time when Medicare recipients can comparison shop and make changes to their plans. It's also a time when scammers take advantage of older consumers with ruses like these:

- Someone calls and says you must join their prescription plan or you'll lose your Medicare coverage. Don't believe it. The Medicare prescription drug plan (also known as Medicare Part D) is voluntary and does not affect your Medicare coverage.
- Someone calls or emails claiming they need your Medicare number to update your account, get you a new card, or send you Medicare benefit information. It's a scam. If you need help with Medicare, call 1-800-MEDICARE or go to medicare.gov.
- Someone claiming to be a Medicare plan representative says they need "to confirm" your billing information by phone or online. Stop. It's a scam. Plan representatives are not allowed to ask you for payment over the phone or online.
- Dishonest companies may offer you free medical exams or supplies. Be wary. It may be a trick to get and misuse your personal information.

Whenever someone asks for your bank account number or your Medicare number, stop. Only give personal or financial information when you have verified who you're talking to. Call 1-800-MEDICARE to make sure you're talking to a legitimate representative.

If you believe you or some you know is a victim of Medicare fraud, report it to the U.S. Department of Health and Human Services. Call the Senior Medicare Patrol at 702-486-3403 or visit stopmedicarefraud.gov.

If you gave out personal information, call your banks, credit card providers, health insurance company, and credit reporting companies immediately. The FTC's website has more information on health care scams and medical identity theft.



Our 26th Commandant, General Louis Wilson, once said, "In the last analysis, what the Marine Corps becomes is what we make of it during our respective watches. And that watch of each Marine is not confined to the time he spends on active duty. It lasts as long as he is 'proud to bear the title of United States Marine. "Thank you all for guarding the legacy of our Corps during your watch.

## November 12, 1954 Ellis Island Immigration Station Closes



The first Ellis Island Immigration
Station officially opens
on January
1, 1892, with
three large

ships waiting to land. Seven hundred immigrants passed through Ellis Island that day, and nearly 450,000 followed over the course of that first year. The next five decades, saw more than 12 million people passing through the island on their way into the United States.

On January 1, 1892—her 15th birthday—Annie Moore from County Cork, Ireland, became the first person admitted to the new immigration station on Ellis Island. On that opening day, she received a greeting from officials and a \$10.00 gold piece. Annie traveled to New York with her two younger brothers in steerage aboard the **S.S. Nevada**, which left Queenstown (now Cobh) on December 20, 1891 and arrived in New York the evening of December 31. After being processed, the children were reunited with their parents, who were already living in New York.

Many famous figures passed through Ellis Island, many leaving their original names behind on their entry into the U.S. Israel Beilin-better known as composer Irving Berlin-arrived in 1893; Angelo Siciliano, who arrived in 1903,

later achieved fame as the bodybuilder Charles Atlas. Lily Chaucoin arrived from France to New York in 1911 and found Hollywood stardom as Claudette Colbert. Some were already famous when they arrived, such as Carl Jung or Sigmund Freud (both 1909), while some, like Charles Chaplin (1912) would make their name in the New World.

Ellis Island opened as a federal immigration station on January 1, 1892, a purpose it served until **November 12, 1954**. Millions of newly arrived immigrants passed through the station during that time—it has been estimated that close to 40 percent of all current U.S. citizens can trace at least one of their ancestors to Ellis Island.
